Who We Are

Information That We Collect

How We Use Your Personal Data

Plunkett Yates Limited takes your privacy very seriously and will never disclose or share your data without your consent; unless required to do so by law. We only retain your data for as long as is necessary and for the purposes specified in this notice. The purposes and reasons for processing your personal data are detailed below: -

- We collect your personal data in order to perform our contractual service as accountants and tax advisors and to ensure that we can contact you.
- We will occasionally use the information to send you information on services where we have assessed that it is beneficial to you as a client.

Your Rights

You also have the right to request erasure of your personal data or to restrict processing (where applicable) in accordance with the data protection laws; as well as to object to any direct marketing from us. Where applicable, you have the right to data portability of your information and the right to be informed about any automated decision-making we may use.

If we receive a request from you to exercise any of the above rights, we may ask you to verify your identity before acting on the request; this is to ensure that your data is protected and kept secure.

Sharing and Disclosing Your Personal Information

We do not share or disclose any of your personal information without your consent unless there is a legal requirement.

Safeguarding Measures
